### **PURPOSE OF A VISA**

The SINGLE entry visa only enables the holder to proceed to the port of entry before the expiry date of the visa issued, where the holder **MUST** comply with the **laws, regulations and requirements** of the Immigration Officials of **the Government of Grenada**. Applicants are advised to seek information regarding regulations and processing procedures with the High Commission for Grenada, before making fixed travel arrangements.

## REQUIREMENTS FOR PROCESSING

### VISA APPLICATIONS PRIOR TO ARRIVAL IN GRENADA

1. Application **MUST** be completed in **BLUE** or **BLACK** ink.
2. Applications **MUST** be made at least **6 weeks PRIOR** to departure date.
3. The processing time for the application is approximately **ten (10) business days** from date of receipt.
4. Applicant's passport **MUST** be valid for at least **6 months from date of departure from Grenada** and accompany application.
5. Only a **FULLY COMPLETED** Visa Application Form will be accepted.
6. **TWO (2)** Passport pictures (*no more than 3 months old*), one certified by a **Justice of the Peace** or a **Notary Public**.
7. Application for a **Single-Entry** Visa is **£78.00** per applicant.
  - i. **ONLY** Sterling Postal Order
  - ii. **CASH or Cheques** accepted **IN PERSON ONLY**.



- iii. If the Visa is to be mailed back to you, please include a **separate Postal order** of **£7.00** for Express Service (*mailing within the U.K.*). Postal orders are payable to **High Commission for Grenada**. For persons outside the United Kingdom, please made arrangement with a courier service in your country of residence
8. Visas are valid for only the period of time specified.
9. Holders of Visas may not work in Grenada unless authorized to do so by the local Ministry of Labour.
10. **REQUIRED DOCUMENTS TO BE SUBMITTED FOR ISSUANCE OF VISA:**
  - i. Passport
  - ii. Completed Visa Application
  - iii. Passport valid for at least **6 months from date of departure from Grenada**
  - iv. Two (2) passport pictures (*no more than 3 months old*), one certified by a **Justice of the Peace** or a **Notary Public**
  - v. If you are a Permanent Resident of the U.K (*Please bring your Residency Card with you*)
  - vi. One money order for visa fee and if applicable, another money order for the return of the passport
