PURPOSE OF A VISA

The SINGLE/MULTIPLE entry visa only enables the holder to proceed to the port of entry before the expiry date of the visa issued, where the holder **MUST** comply with the **laws, regulations and requirements** of the Immigration Officials of **the Government of Grenada**. Applicants are advised to seek information regarding regulations and processing procedures with the High Commission for Grenada, before making fixed travel arrangements.

REQUIREMENTS FOR PROCESSING

VISA APPLICATIONS **PRIOR TO ARRIVAL** IN GRENADA

1. Application **MUST** be completed in **BLUE** or **BLACK** ink.
2. Applications **MUST** be made at least **6 weeks PRIOR** to departure date.
3. The processing time for the application is approximately **ten (10) business days** from date of receipt.
4. Applicant's passport **MUST** be valid for at least **6 months from date of departure from Grenada** and accompany application.
5. Only a **FULLY COMPLETED** Visa Application Form will be accepted.
6. **TWO (2)** Passport pictures (*no more than 6 months old*)
7. Fees:

Single-Entry - £200.00 per applicant.

Multiple-Entry - £375.00 per applicant



- i. If the Visa is to be mailed back to you, please include a **prepaid special delivery envelope** (*mailing within the U.K.*). For persons outside the United Kingdom, please make arrangements with a courier service in your country of residence
8. Visas are valid for only the period of time specified.
 9. Holders of Visas may not work in Grenada unless authorized to do so by the local Ministry of Labour.
- 10. REQUIRED DOCUMENTS TO BE SUBMITTED FOR ISSUANCE OF VISA:**
- i. Passport
 - ii. Completed Visa Application
 - iii. Passport valid for at least **6 months from date of departure to Grenada**
 - iv. Two (2) passport pictures (***no more than 6 months old***),
 - v. If you are a Permanent Resident of the UK (*Please bring your Residency Card with you*)
 - vi. *Payment*

Cashless Payments for Consular Services

Please be advised that the High Commission for Grenada in London will transition to cashless payments for all consular services effective **March 3, 2025**.

Payments can be made via the following options:

- ***Credit Card/ Debit Card*** – Payments can be made using major credit or debit cards. A transactional fee of £2.00 will be charged per transaction.
- ***Online Bank Transfer*** – Payments can be transferred to the account via your online banking platform.
- ***Bank Deposit*** – Payments can be made via the bank directly into the account. Kindly note that customers may be asked for the deposit receipt.
- ***[Pay.gov.gd](https://pay.gov.gd)*** – Kindly note if payments are made via this option, persons will need to walk with their receipts and pay the processing fee for passport applications at their appointment.
