



GRENADIAN PASSPORT & VISA FEES

With effect from 1 July, 2024

Passport Application (renewal and First Time) (6 Weeks):

- ❖ £195.00 (36 pages – 5 yr) (From birth to 17 years)
- ❖ £277.00 (36 pages – 10 yr) (18 years and above)
- ❖ £30.00 – **PROCESSING FEE**

Lost, Damaged, Early Application:

- ❖ **£553.00** – If the passport has **not expired** (Age 18 and above)
- ❖ **£277.00** – If the passport **has expired** (Age 18 and above)
- ❖ **£390.00** – If the passport has **not expired** (From birth to 17 years)
- ❖ **£195.00** – If the passport **has expired** (From birth to 17 years)
- ❖ **£30.00** – **PROCESSING FEE**

Fast Track (2 weeks)

- ❖ **£234.00** – 36 pages, 5-year validity (From birth to 17 years) – Fast-track service if passport **is expired**
- ❖ **£429.00** – 36 pages, 5-year validity (From birth to 17 years) – Fast-track service if passport **has not expired**
- ❖ **£316.00** – 36 pages, 10-year validity (18 years and above) – Fast-track service if passport **is expired**
- ❖ **£592.00** – 36 pages, 10-year validity (18 years and above) – Fast-track service if passport **has not expired**
- ❖ **£30.00** – **PROCESSING FEE**

An additional £160.00 fee applies for Fast Track courier services.

Emergency Travel Document

- ❖ £26.00
- ❖ £ 30.00 - **PROCESSING FEE**

Visa Fees

- ❖ £200.00 - Single Entry
- ❖ £375.00 - Multiple Entry
- ❖ £30.00 – **PROCESSING FEE**

Postage - UK:

- ❖ Should you require the passport to be posted back to you, applicants can purchase a prepaid special delivery envelope from their local post office and enclose it along with the application.

- ❖ Applicants residing outside the United Kingdom must arrange for a courier service (e.g., FedEx or DHL) in their country of residence to collect the passport from the High Commission. The airway bill must be emailed to our office in advance.

Cashless Payments for Consular Services

Please be advised that the High Commission for Grenada in London will transition to cashless payments for all consular services effective **March 3, 2025**. Payments can be made via the following options:

- ***Credit Card/ Debit Card*** – Payments can be made using major credit or debit cards. A transactional fee of £2.00 will be charged per transaction.
- ***Online Bank Transfer*** – Payments can be transferred to the account via your online banking platform.
- ***Bank Deposit*** – Payments can be made via the bank directly into the account. Kindly note that customers may be asked for the deposit receipt.
- ***[Pay.gov.gd](https://pay.gov.gd)*** – Kindly note if payments are made via this option, persons will need to walk with their receipts and pay the processing fee for passport applications at their appointment.
